The Diocese of Lichfield has officially been recognised as a dementia friendly community since April 2017 by the Alzheimer's Society's Dementia Friendly Communities Team, as part of their focus on improving inclusion and quality of life for people with dementia in a number of ways. As such, we are able to authorise churches in the diocese to use the national "Working to become Dementia Friendly" logo, provided that the church agrees a three-point Action Plan for the year ahead.

This is how a dementia friendly community is described:

*"A dementia-friendly community is a city, town or village [or diocese!] where people with dementia are understood, respected and supported and confident they can contribute to community life."*

These notes are to assist in completion of the Certificate.

- CHURCH/CHURCHES:** The Action Plan can either be for an individual church or for a group of churches e.g. a benefice. It is the choice of the church/churches involved, but approval needs to be given by a person/body that can speak for all churches covered by the Action Plan. For a group of churches, we can provide one copy of the certificate to display in each participating church.
- ACTIONS:** The actions need to be specific, realistic and achievable. They can be small steps forwards, but they must be steps that you can and will take in the year ahead. We can share with you examples of possible actions. This certificate records the agreed 3-point Action Plan. You can commit to more actions if you wish – but it is better to deliver on three points than to commit to more and not deliver! You are welcome to include these actions in your Mission Action Plan, if you so chose.
- DEMENTIA-FRIENDLY CHURCH CONTACT NAME:** Please specify the name of the person who is your Dementia-Friendly Church contact. This is the person who will be contacted to review the Action Plan in a year's time: we hope and expect that you will be confirming that this year's actions have been completed and that you will be ready to sign up to three more actions for next year, to entitle you to use the logo for a further year.
